ELIGIBILITY: The Sweepstakes is open to drivers who have an active driver account on the Uber platform (see requirements at https://www.uber.com/us/en/drive/requirements/?uclick_id=c2eec292-7f39-4d00-b4d3-c22aa1565695) who are legal United States residents residing in the forty-eight (48) contiguous United States and the District of Columbia who are at least twenty one (21) years of age or older at the time of entry (each, an "Entrant"). - i. **Registration Form:** Visit <u>www.hertz.com/goelectric</u> to complete and submit the registration form in its entirety to include first name, last name, email address and phone number to receive one (1) entry into the Sweepstakes.
- B. Bonus Entries: Entrant must submit an Initial Entry in order to obtain Bonus Entries.
 - i. Entrants renting with Hertz at start of Sweepstakes: Upon completing and submitting an Initial Entry, an Entrant who is currently renting with Hertz as of the start of the Sweepstakes on June 10, 2024 in a Hertz EV Rental through the Hertz Rideshare Program with Uber will receive five (5) entries into the Sweepstakes.
 - ii. **Hertz EV Rental:** Upon completing and submitting an Initial Entry, an Entrant who completes a Hertz EV Rental through the Hertz Rideshare Program for four (4) weeks or less within the Sweepstakes Period will receive ten (10) entries into the

Sweepstakes. An Entrant who completes a Hertz EV Rental through the Hertz Rideshare Program for five (5) weeks or more within the Sweepstakes Period will receive twenty (20) entries into the Sweepstakes.

iii.
